Overview

We began the 2021-2022 school year hopeful that we would soon return to the "new normal," whatever that meant. Most schools opened their doors with students wearing masks and maintaining a safe distance from each other. Administrators spent the first couple of board meetings discussing with each other the protocols that were in place at their schools. Throughout the year, administrators continued to struggle with the next COVID strain and/or surge that moved through their schools, districts and across the state. Schools and districts did what they could to stay open, with principals often doing their own job as well as filling in for faculty and staff who were out due to COVID. So, "just when you thought it couldn't get any worse… it did!" Toward the end of the school year, for the most part, people just decided to live their lives and treat COVID like the flu. Even though COVID numbers continued to increase, especially after holidays, schools were able to hold many of the end of the year traditions (e.g., student activities and events) that had been canceled during the previous two school years.

The Middle Level Board of Control continued meeting virtually this year. We had four formal meetings during the year and one informal coffee hour where we just met and talked about whatever was on anyone's mind. The Middle Level Board also continued to share resources with each other during meetings and via our shared Google Drive file folders.

A special thank you to all of the Middle Level Board of Control members who provided guidance and support to CAS as well as sharing their leadership and expertise with colleagues across Connecticut.

Middle Level Board Meetings

The Middle Level Board members remained the same as the previous 2020-2021 school year. This allowed the Board to pick up and continue where they left off last year.

The Board spent time at each of their meetings discussing their "survival" issues, primarily Covid protocols and logistical concerns, SEL and trauma for students and staff, and wellness, self-care and staff morale issues. There were other topics of interest for discussion this year, but these tended to take a "backseat" to the survival issues and concerns. Other topics of interest include: Social and Racial Justice; Equity; building relationships and community now that everyone is back in school; books and articles members were reading for their own professional growth or with faculty and staff for professional learning; and, of course, increasing CAS membership and participation.

The Middle Level Board of Control did not set the meetings for the 2022-23 school year yet. The meeting dates and times will be decided during the summer for next year.

NAESP and NASSP National Leadership Conference and Virtual Capitol Hill Day

This year the NAESP and NASSP National Leadership Conference took place in person in Washington DC. However, most of the meetings with the Senators, Representatives and/or their staff were held virtually. An advocacy team of principals from Connecticut attended the National Leadership Conference in person for the NAESP and NASSP meetings. The Advocacy Team of Principals representing CAS included: Mike Litke, Scott Nozik, Katheleen Gombos, and Andre Hauser. The Advocacy Team met with members of the CT delegation either in person or virtually via Zoom. CAS staff also attended the meetings virtually with our Connecticut Delegation.

NAESP, NASSP, NELMS and AMLE

During the year, NAESP CT State Representative, Mike Litke, and NAESP CT Federal Relations Representative, Scott Nozik, provided written reports to the CAS Middle Level Board of Control. NAESP is planning an in-person conference in Louisville Kentucky July 15-17, 2022.

AMLE's Annual Conference was held in-person in Louisville, Kentucky, November 4-6, 2021. The AMLE22 Conference is November 3-5 in Orlando, Florida. NASSP will not hold their National Principals Conference this summer. The NELMS virtual conference was March 18-19, 2022.

ROPES Elementary and Middle Level Principal Networking

Diana Burns, Principal of Chapman School in Cheshire serves as the Chairperson for CAS ROPES committee. ROPES provides networking opportunities for Pre-K through grade 8 principals and assistant principals. ROPES stands for Reciprocal Opportunities for Principals to Engage with each other Synergistically. The networking meetings provide opportunities to: problem-solve issues; share and celebrate successes; swap resources and best practices; and discuss current challenges and "hot topics."

The CAS ROPES Committee met virtually several times during the year to plan for the ROPES meetings. The ROPES Committee planned two different events for in person networking meetings at Vespucci's Restaurant in Cheshire. Both events were canceled due to a small registration. However, the February 17, 2022 St. Patrick's Day virtual networking event did occur and participants were excited to see and talk with each other. The ROPES Committee is hopeful that people will be able to join meetings in person next year. They

also plan to set the dates early in the year for meetings, making sure the dates and times conflict as little as possible with other meetings and events.

Professional Development

Due to COVID-19, the Center for Leadership and Innovation (CLI) did all of their webinars and meetings virtually this year. The CLI hosted a variety of professional learning webinars that were appropriate for middle level administrators and their school communities. Of particular interest to middle school administrators were the legal webinars and those that dealt with administrator and staff wellness, morale, and self-care. There was also a lot of interest in SEL and trauma webinars.

The CLI also hosted three Virtual Education Equity Summits. Middle Level Board Member, Nilda Irizary, who was also the 2020 Outstanding Middle Level First Year Principal, presented at the third equity summit. A large focus for CAS this past year has been Diversity, Equity and Inclusion. In the spring of 2021 a CAS Equity Committee was formed and met regularly during the year to design and produce three educational equity summits.
