

# An Invitation to Nominate an Outstanding CAS Elementary School as CAS Elementary School of the Year 2015-2016

(Deadline for Submission is August 20, 2015)

Nominations may be made by any present or former member of the school staff or by district central office personnel.

### **Purpose:**

To give public recognition to an outstanding **CAS member elementary school** that deserves major recognition for its exemplary programs in meeting the needs of elementary school students. The school chosen will receive recognition in the media, in CAS publications, at a CAS sponsored ceremony in their community as well as a presentation in their school or district.

#### **Eligibility:**

The following criteria will be used to determine the recipient of this award:

#### A. School must be a member of CAS.

- B. Provide evidence of the characteristics of a high-performing school by describing:
  - 1. Your school's mission/vision.
  - 2. How your educational programs meet the needs of <u>all</u> students.
  - How instructional and administrative leadership implements the requirements of the teacher and administrator evaluation.
  - 4. How the school welcomes participation from all constituencies.
  - 5. How curriculum and instruction is aligned with the Connecticut core state standards and professional development.
  - 6. How the school's educational programs are consistently reviewed and improved.
  - 7. How student opportunities go beyond those that are a part of a typical school day, i.e., clubs, activities, support services and extra help for those who need it.
  - 8. How the school welcomes family involvement and plays an active role in the community. (Refer to the attached graphic)
- C. Each of the eight criteria must be individually addressed. The total response <u>must not exceed 10 pages</u> (12 point font/single spaced).
- D. Only one application per district will be accepted.
- E. A copy of the strategic profile <u>must</u> accompany the application.
- F. A copy of the student/parent handbook <u>must</u> accompany the application along with the school's website
- G. The selected school will be invited to share exemplary practices and programs with other CAS elementary schools by offering CAS workshops, and welcoming visitors to their school.
- H. Selected school will be recognized at the CAS Celebration of Excellence on November 9, 2015.
- I. Deadline for submission of nominations is no later than August 20, 2015.
