**CAS High School Dues include:**

- ◇ **CAS** General Membership including a subscription to the "Bulletin" and member discounts for all CAS activities and events
- ◇ **CIAC** Membership including **\$250** for Federation Fund Insurance
- ◇ **CAAD** Membership. The Connecticut Association of Athletic Directors (CAAD), a subsidiary of CAS-CIAC is dedicated to improving and supporting the work of high school athletic departments. CAAD exists to serve schools and not the welfare needs of athletic directors. *Schools not interested in CAAD membership may deduct \$135 from their dues.*
- ◇ **CANHS** Membership. The Connecticut Association of National Honor Societies (CANHS), a subsidiary of CAS, is an outgrowth of the National Honor Society which believes that a state organization can better meet the needs of the local chapters in the areas of training, selection, service projects, scholarship recognition and character development. *Schools not interested in CANHS membership may deduct \$50 from their dues.*
- ◇ **CASC** Membership. The Connecticut Association of Student Councils, a subsidiary of CAS, creates opportunities for high school students to learn and practice leadership skills and to provide training for club and activity advisors. CASC is committed to developing skills around issues of respect, diversity, sportsmanship, and healthy life styles. *Schools not interested in CASC membership may deduct \$50 from their dues.*
- *CAS Constitution – Article IV, Section D.2.d. "Annual dues shall be due and payable on September 1 of each school year." Middle and high schools that share the same building and the same administration will receive high school and middle level services if they enroll as high schools and pay high school dues.*
