Via Route 395 South: Exit 77 – Rt. 85, Left off exit pass the Crystal Mall and continue straight until the intersection of Coleman & Broad. Take Right onto Coleman Street. Take Right onto Bank Street then immediate left onto Lee Avenue. Right onto Ocean Avenue. Left at Squire Street

Via I-95 North: Exit 75 (Waterford) Route 1 Continue straight through at 6th light take a Right onto Willetts Avenue, take left at next light onto Rt. 213 (Ocean Avenue). Third right is Squire Street.

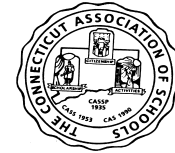
West (Waterbury): I-84 East to I-691. I-691 turns into Rt. 66 East. Follow Rt. 66 passing the shopping center and numerous gas stations, after you pass under railroad bridge, take a right at the light onto Vine Street. At end of street take left onto Church Street and follow Church Street through one stop sign, down the hill through one light. At second corner turn right onto Hubbard Street. Pass the shrine town and enter the second parking lot on left (behind school)

South East (Madison/Old Saybrook): Rt. 9 to Exit 12, left at stop sign, right onto Saybrook Road. Follow Saybrook Road for about 1-2 miles under the bridge turning left immediately after the bridge, up the ramp for short block to the circle. Turn right onto South Main Street. The front of the school will be on the left. Pass school and take a left at the next light onto Church Street and then left onto Hubbard Street – Parking lot is on your left (behind school).

North (Hartford): I-91 South to Exit 14. Cross railroad tracks and go straight through Main Street. At second light left onto Broad Street. First right onto Church Street and left onto Hubbard Street. Pass the shrine town and enter the second parking lot on left (behind school)

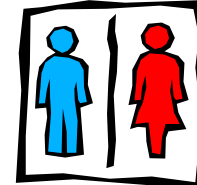
South (New Haven): I-91 North to Exit 66 East. Follow 66 East – Continue with above directions from Waterbury.

Presently Dr. Bennett is an adjunct professor at Sacred Heart University in Bridgeport. He received numerous awards & honors, and in 1978 was named Connecticut "Man of the Year" by the late Governor Grasso. His numerous publications include: *"Getting Ready for the 21st Century," "To Obey or Not to Obey," "A Manual For Good Classroom Management,"* & *and "Viva La Difference,"* an article for "The School Administrator."
