

# Q10 Should the NFHS consider mandating them as regular equipment like the shin guard given our ankle injury data?





# Q11 Does your state require mouth guards in soccer?



## Q12 Does your state use fourth officials during state Championships?





# Q13 If yes to #12, which games?



## Q15 Do you have a state soccer ball contract?




# Q19 Does your state set a mileage rate for regular season varsity contests?







# Q23 Does your state restrict post-season eligibility based on number of cards issued to a player?





# Q33 Is the use of protective headgear for concussion management increasing, decreasing or staying about the same in your state?





### Q35 Does your state fully adhere to all the new uniform requirements or have you modified the rules by state adoption?







# Q37 Does your state allow teams to wear uniform socks against the NFHS rules to celebrate special activities like breast cancer awareness with pink socks?





# Q38 Does your state make accommodations for student-athletes who must wear head coverings for religious reasons?





### Q39 Does your state make accommodations for non-English speaking officials on their tests?





# Q40 What officiating system is most often utilized in your state for junior varsity season high school contests:





# Q41 What officiating system is most often utilized in your state for varsity season high school contests:





