

## 2022-23 Annual Report CENTER FOR LEADERSHIP AND INNOVATION Submitted by Dr. Alicia Bowman CAS Associate Executive Director and CLI Director

The Connecticut Association of Schools established the Center for Leadership and Innovation to address the professional learning and related needs of aspiring and practicing school leaders. The work of the Center is guided by an advisory committee of active principals and assistant principals.

Based on the results of a needs assessment conducted in the summer of 2022 and feedback from our elementary, middle level and high school boards, CAS staff worked collaboratively with the CLI advisory committee to design professional learning opportunities around the issues that were most important to our members. We hosted both in-person and virtual events in alignment with the feedback that we received on both structure and content of member interests and needs.
