#### CONFERENCE RATIONALE

CAS believes it is important for school leaders to connect the present drive for students to know more and do more to the realities of the rapidly changing world today's students will enter. The vision stated in the *Framework for Connecticut's High Schools* – that students will graduate as contributing citizens prepared for college and work in a global society – can only be fulfilled if K-16 reform changes schooling in this state in significant ways. Why, then, this conference? Because . . .

- NCLB means more than new test demands and daunting AYP requirements. Its intent is a rigorous and relevant education for every student in order to succeed in the world beyond high school – and that world is technologically rich and increasingly interconnected.
- NAESP supports the ongoing process of assessment at the elementary level. This would include development of an improvement plan based on the analysis of the data generated in classrooms and schools in an effort to meet annual yearly progress.
- NASSP has just released *Breaking Ranks in the Middle*, a real "hands-on" guidebook for principals and school leadership teams to systemically improve middle schools and the performance of their students.
- A blue ribbon task group has forwarded to the Commissioner and State Board of Education a framework for the new Connecticut High School, a document with implications for educators and their students from kindergarten through college.
- Over 60 schools to date are participating in the CT-Shandong Province Education Partnership initiative with up to two dozen more sister school partnerships scheduled to come on line this year. Shouldn't some form of similar outreach be present in every one of Connecticut's schools?

#### Christopher Dede, Timothy E. Wirth Professor in Learning Technologies, Harvard Graduate School of Education

Chris Dede's fundamental interest is the expanded human capabilities for knowledge creation, sharing, and mastery that emerging technologies enable.
