

## **GENERAL SESSIONS**

#### THE OTHER CRT: CULTURALLY RESPONSIVE TEACHING IN AN AGE OF MASS DISRUPTION

Dr. Yohuru Williams, Founding Director of the Racial Justice Initiative at the University of St. Thomas During this morning keynote, Dr. Williams explores the importance of Culturally Responsive Teaching in response to the unprecedented events of the last year from the murder of George Floyd and the global pandemic to the hate crimes against Asian Americans and climate change. Dr. Williams illustrates the ways in which Culturally Responsive Teaching can serve as the background and foundation for a reimagination of the future through the development of responsible, well-rounded, and culturally aware students and citizens.

#### TOOLS FOR ANTIRACIST EDUCATION IN THIS HISTORICAL MOMENT

Drs. Daren Graves & Scott Seider, Co-Authors of "Schooling for Critical Consciousness" This afternoon keynote will reflect upon concepts and practices raised over the course of the summit and offer some closing thoughts about engaging in antiracist education in this important historical moment. Specifically, how can we as educators respond to an historical moment that includes a heightened urgency in many school and communities to name and challenge racism and a willingness to consider new and different schooling approaches, but also increasingly fierce resistance to antiracist education from some politicians, parents, and pundits? The keynote will conclude with an opportunity for summit participants to reflect upon their own next steps for supporting equity and antiracism in their own schools and classrooms.

#### STUDENT EQUITY ADVISORY BOARD PANEL DISCUSSION

Moderated by Cherese Miller and Henry Rondon, CT Association of Schools

During this panel discussion, student leaders from across Connecticut will share their perspectives on equity through the lens of race, culture and identity. Panelists will explore findings of student-led research conducted in 2020-21 and will discuss equity-driven work undertaken within their schools

and communities. In addition to sharing perspectives, students will be offering recommendations for change based on their research findings.
