ELIGIBILITY

Representational or Abstract. All mediums including Oils, Watercolors, Graphics, Acrylics, Computer generated pieces, Monotypes, Photography, etc. may be submitted.

Due to the constraints of the exhibit venue, only 2-dimensional work can be accepted. No sculpture/3-dimensional works can be considered.

All works must be original and may be for sale. Sale price must include frame. All artwork MUST be framed and ready to hang with screw eyes and wire, or cannot be accepted. Overall size of the artwork cannot exceed 42" x 48".

Each entrant must be an educator presently working in Connecticut. Each educator may submit up to 6 pieces for consideration. Photographs are much preferred for jury, but slides will be accepted. Each photo or slide must have securely attached to it a completely filled out entry form or it cannot be considered. Photo or slide must be marked with title and artist name

Sales: A 25% commission will deducted for the purchase price of all sales.
