Minutes

May 10, 2022

1. WELCOME. Mr. Simon welcomed the group to the meeting which was held jointly between the boys and girls basketball committees. The meeting was held via zoom.
2. SURVEY - 173 to 27 voted to accept the proposal for establishing a shot clock for the 23-24 school year. There was strong participation in the survey.
 - a. The proposal now goes to the Board of Control who will meet in August.
 - b. Mr. Simon will send a message to the Athletic Directors.
3. DECEMBER JAMBOREE
 - a. Invitations went out to 4 teams based on the recommendation of the committee.
 - b. December 27th is the date.
 - c. 11:00, 1:30, 4:00 and 6:30 are the possible start times.

GIRLS' COMMITTEE MEETING - The boys' committee adjourned from the meeting and the girls' committee continued.

1. SUCCESS IN TOURNAMENT -
 - a. Tim Kohs presented the committee with an alternative for "Success in Tournament" Formula.
 - b. A team that wins a championship should not have the same movement as a team that doesn't. There should be more weight given the further a team moves forward.
 - c. The girls' committee discussed the proposal.
 - d. This proposal affects schools of choice only.
 - e. For the present we won't have three years of data.
 - f. The committee voted to "approve the proposal in concept and will discuss it further in future meetings."
2. Mr. Simon gave a report on the success in tournaments for schools of choice for the past years.

CIAC Girls Basketball Success in Tournament (updated 5/13/22)

Applies to Schools of Choice – Currently 67 of 180 schools / 37%

Current Format: Reach the ¼ Finals 1 of last 3 years = Move up 1 Division
 Reach the ¼ Finals 2 of last 3 years = Move up 2 Divisions
 Reach the ¼ Finals 3 of last 3 years = Move up 3 Divisions

Currently, if a team goes 2-1, or in some cases, 1-1 in the State Tournament they will play up a division for the next three years. That team may or may not win a game in the tournament over the next three years. A team can also go 3-3 - 6-3 over a three-year period and be moved up 3 divisions without ever winning a semifinal game.

The value of reaching the ¼ Finals and winning a State Championship should not be the same. In the old format, a team that reached three consecutive ¼-finals **without winning that round** was moved up 1 division higher than a team that won 2 State Championships over the same three year period.

The new system continues to use the previous three years of data but incrementally places more value on each successive win (starting with the second round) as a team progresses through the state tournament.

The proposal for a new Success in Tournament Factor formula was approved at the May 10th CIAC Girls Basketball Committee meeting. Up for discussion is the point system required for movement.

Proposed point system for movement is listed below:

A weighted scale placing more value on wins attained in each round of the tournament keeping the 3-year look-back period.

New Point System for discussion

A team reaching the ¼ Finals receives	1 point		
A team reaching the Semi-Finals receives	2.5 points	or	+ 1.5
A team reaching the Championship game receives	4.5 points	or	+ 2
A team winning a State Championship receives	7 points	or	+ 2.5
