To participate in this program, registration must be completed electronically via the CAS-CIAC web site. To submit your information, please click on the member schools login link in the upper left-hand corner of the CAS-CIAC home-page. Enter your school number and login ID and after successfully logging in, select *Submit CAS Recognition of Excellence Celebration* form. Please provide the following:

- 1. Name of the program or staff contribution being recognized along with a description.
- 2. Name(s) of the award recipient(s) who will be attending the banquet, as well as the names of any additional members from your school and district who will also attend.

DIGITAL PICTURES:

Please send two digital pictures: One of the program or activity; and one of the award recipients being recognized to Erin Guarino at <u>eguarino@casciac.org</u> by October 19, 2015. These digital pictures should be high resolution with a file size of approximately 2 mg. each. Larger file sizes are fine as well. Pictures may be either .tiff or .jpeg files. Please do not embed the pictures in a word file as this limits the file size when we try to extricate them. Screen shots from online are not appropriate for this event as the file sizes are too low. If you are using your iPhone to take and send the pictures, please select the highest file size option when sending (actual size 871kb). Please remember that your pictures will be blown up onto a large screen at the event and we want your pictures to look great!

COST TO MEMBER SCHOOLS:

The cost to attend this event is \$30.00 per person. For member schools, the cost of the plaque will be borne by the Connecticut Association of Schools. Non-member schools will pay an additional fee of \$100.00.
