Preventing Targeted Violence in Schools Safe School Initiative Seminar

Seminar Description

In response to concern about the safety of America's schools and school children from acts of targeted violence committed by students, the Secret Service's National Threat Assessment Center (NTAC) will conduct a **Safe School Initiative Seminar on Tuesday**, **June 29 from 8:00 a.m. to 3:30 p.m**. This seminar will take place at Central Connecticut State University's Lawrence J. Davidson Hall in the Torp Theatre. The NTAC will present select case studies of school shooters, discuss the study's findings, and examine the concept of threat assessment as an approach to evaluating the risk of targeted violence in schools.

The goal of this seminar is to provide information and materials from the Safe School Initiative in order to help attendees develop and implement strategies to earlier identify, assess, and manage those that may pose a risk of targeted violence in schools. The Safe School Initiative gathered and analyzed operationally relevant information about the thinking and behavior of students who have planned and carried out instances of targeted violence in American schools over the past several years.

Seminar Objectives

Upon seminar completion, participants will:

- Realize the concepts of targeted violence
- Discover the current approaches to evaluating risks for targeted violence in schools
- Receive the findings from a study of the pre-incident thinking and behaviors of school shooters in the U.S. in the past 25 years
- Learn the principles of threat assessment as a better means to evaluate risk of targeted violence in schools

Directions to CCSU's Welte Garage (#40 on the CCSU map)

From the EAST

Take I-84 West to Exit 39A to Rt. 9 South. Take Exit 29 off of Rt. 9 to Ella Grasso Boulevard and take a right turn to the University. Proceed approximately ³/₄ mile and take a left at the 4th light into the Welte Garage (before reaching the intersection of Grasso Blvd. and Stanley St.).

From the WEST

Take I-84 East to Exit 35, Rt. 72 East (New Britain Exit). Follow Rt. 72 East to Rt. 9 North and take Exit 29 to Cedar Street (Rt. 175). At the traffic light at the end of the ramp, take a left turn to the second traffic light, and take a right turn onto Paul Manafort Drive to the University. Proceed approximately 3/4 mile to the traffic light and take a right onto Stanley Street. Take a right just after the blue sign marking Welte Garage (BEFORE the next traffic light).

From the SOUTH (New York area)

Take I-95 North to I-91 North to Exit 22 North to Rt. 9 North. Follow Rt. 9 to Exit 29, Cedar Street (Rt. 175). At the traffic light at the end of the ramp, take a left turn to the second traffic light, and take a right turn onto Paul Manafort Drive to the University. Proceed approximately 3/4 mile to the traffic light and take a right onto Stanley Street. Take a right just after the blue sign marking Welte Garage (BEFORE the next traffic light).

From the NORTH (Rhode Island area)

Take I-95 South to Rt. 9 (Old Saybrook). Take Rt. 9 North to Exit 29, Cedar Street (Rt. 175). At the traffic light at the end of the ramp, take a left turn to the second traffic light, and take a right turn onto Paul Manafort Drive to the University. Proceed approximately 3/4 mile to the traffic light and take a right onto Stanley Street. Take a right just after the blue sign marking Welte Garage (BEFORE the next traffic light).

From the NORTH (Massachusetts)

Take I-91 South to I-84 West to Exit 39A, to Rt. 9 South. Take Exit 29 off Rt. 9 South to Ella Grasso Boulevard and take a right turn to the University. Proceed approximately ³/₄ mile and take a left at the 4th light into the Welte Garage (before reaching the intersection of Grasso Blvd. and Stanley St.).
