Outstanding First-Year Principal Award

1. How has the nominee's instructional leadership, innovative practices, and managerial or organizational skills had a positive impact on the school district this year?

As a first-year principal of Dodd Middle School in Cheshire, Mr. Jeff Solan is an innovative instructional leader who possesses strong interpersonal and organizational skills that contribute to his success as an educational leader. His impact on the Cheshire Public Schools has been significant. He exemplifies the attributes outlined in Connecticut's Common Core of Leading. Jeff works with staff members, parents, and students to translate the school's vision into school-based strategic planning initiatives and objectives. He values the participation of members of the Dodd School community in developing a common understanding of the learning initiatives for the school year and is committed to using student learning as the basis for evaluating school success.

Jeff Solan establishes a climate of collegiality and cooperation where staff members accept collective responsibility for improving the teaching and learning process at Dodd Middle School. He fosters an expectation that teachers engage in conversations about teaching, learning and assessment practices. Meetings at Dodd are focused on student learning and teachers often reflect on the impact of their professional beliefs, expectations, and practices related student learning achievement standards. During the 2008 - 2009 school year, Jeff created a common professional development goal to target a writing need identified through CMT results. He encouraged interested staff members to explore promising instructional and programmatic alternatives to enhance writing achievement at the middle school level for all students, and most

importantly, low performing writers. The achievement results as measured by the Connecticut Mastery Writing Test demonstrated that seventh graders improved from 78% at goal to 81% meeting this standard; and eighth graders moved from 84% to 89% at the goal level standard. Subgroup improvements in writing were even more impressive with 80% of a target group of needy writers moving from basic or below basic levels to proficiency. As an instructional leader, Jeff believes that all students can attain high levels of achievement and respects the unique qualities of each learner. He is committed to helping all students develop self-confidence and competence during the transitional middle school years.

Jeff's leadership style is one that includes others in the decision-making process. He seeks the input of staff members, parents, and community members in determining appropriate organizational structures and resource allocation at Dodd Middle School. Jeff understands the interrelationships among staff selection, staff evaluation, professional development, and school improvement and uses a calm (and at times, humorous) approach to build trust and rapport. Jeff purposefully promotes and reinforces a culture of staff collaboration and collegiality by sharing decision-making authority and delegating responsibility as staff members pursue improved teaching and learning practices. Jeff recognizes and trusts the professional expertise of his staff and links school improvement needs to strategic planning objectives.

Jeff Solan works well with staff members to implement programs and instructional strategies that incorporate diverse perspectives at the middle school level as well as promote the achievement of school strategic planning initiatives. Jeff provides linkages and connections between and among events occurring in and outside of the school environment to enhance the learning process for the

teachers and students as evidenced by his involvement and commitment to the annual Washington D.C. trip. Jeff took an active role in working with his teachers to revise the trip itinerary to make the experience more meaningful and productive for his students including the use of student-made informational videos and podcasts that were available on buses and at various attractions to enhance the learning experience.

Jeff organizes Dodd Middle School with fairness, equity and high expectations for all learners. He encourages and supports his staff as they assume responsibility for their own learning and professional development. Jeff is active in developing his own profession growth as evidenced by his participation in the *Training in Special Education Administration for Principals and Other Administrators* during the 2008 – 2009 school year. He values staff participation in the decision-making process and fosters collaboration and commitment to the development and attainment of school goals. Jeff Solan is not only an outstanding first-year principal; he is an outstanding educational leader!

2. Show how the nominee has shown indications of being a risk taker, a visionary, and the ability to overcome adversity.

Jeff Solan utilizes multiple strategies to shape his vision as well as a welcoming climate at Dodd Middle School so that learning is a priority at Dodd Middle School. Jeff implements many strategies including active listening, a sense of humor and staff collaboration to foster a positive school culture. He believes that school culture has an impact on learning and values norms of collegiality in the pursuit of school goals and strategic initiatives. Jeff encourages school community participation in establishing a positive learning climate and works to include community organizations in the life of the school to enhance learning opportunities for his students. In addition, Jeff works closely with all school constituents to develop shared values of openness, mutual respect, support, and inquiry that promote risk taking and innovation. At Dodd Middle School, stakeholders are empowered through shared leadership and risk taking is part of an environment of trust and collaboration.

As principal of Dodd Middle School, Jeff establishes effective routines and procedures to ensure an organized, safe, and positive learning environment. He makes a concerted effort to be visible and to maintain an open door policy. He is excellent at using skills of consensus building and negotiations to problem solve difficult issues and to support teacher learning and growth. Jeff takes the teacher evaluation and professional growth plan very seriously. He believes that providing ongoing support for staff members to reflect on their roles and practices in light of student standards and school initiatives is an important role as an educational leader. Jeff will

take the necessary steps to help each teacher demonstrate success at meeting the Common Core of Teaching standards.

Jeff Solan assumed several leadership responsibilities beyond the school setting. Jeff served as a leader at the district level in many different capacities during the 2008 – 2009 school year. He served as chair of our Strategic Planning Council which met monthly and developed a survey to elicit input from school community members related to our school district's vision, mission statement, goals and objectives. He lead this group to design questions to gain feedback on how best to revise our current strategic plan. Jeff also was a member of our district's Instructional Technology Committee and worked to research applications that would help measure student technology competencies by the eighth grade. Our 2009 Administrators' Summer Retreat was planned by a committee of interested administrators and Jeff took an active role as a member of this team. Our Retreat was successful because of his input, experience, and willingness to take on the additional responsibilities to help plan and implement the three-day workshop sessions. Jeff Solan an effective leader and outstanding principal.
