Workshops 1 & 2 will help administrators ensure that all preliminary groundwork is in order and evaluations are written appropriately. Administrators may bring actual cases for analysis.

Dr. Ullman is the Superintendent in a school district that has 5.000 students in 5 elementary schools, 1 middle school and 1 high school and is nationally recognized as a top performing school district. Prior to serving as Superintendent, she served as the **Assistant Executive Director of the Capitol** Region Education Council. CREC is a regional service center that provides programs and services to 35 local school districts and operates 8 Interdistrict Magnet Schools, Dr. Ullman earned a Ph.D. in Educational Administration from the University of Colorado, a Master's degree from Northeastern University and an undergraduate degree from Regis College.

Kim Marshall, a former teacher, principal, and district official in the Boston Public Schools, is an independent professional development consultant working with schools and districts nationally on leadership practices. Kim writes for educational journals such as Education Week and Phi Delta Kappa and publishes a weekly online newsletter, The Marshall Memo, summarizing the best ideas and research in education. His groundbreaking 2009 book, Rethinking Teacher Supervision and Evaluation, advocates a broad framework that enlists teachers in improving the performance of their students.

Rethinking Teacher Supervision and Evaluation (4/4 and 4/12)

In his two sessions, Kim will make the case for a new approach to supervision and evaluation and detail the components of his proposed system. The emphasis on April 4th will be on mini-observations with feedback; the focus on April 12th will be on interim assessments.
