#### **Directions:**

#### I-91 from Hartford

Take I-91 South to New haven, Exit 1 (downtown) onto connector. Move quickly over to the right. Look for Coliseum and Railroad Station signs. Take Exit 1 off connector and take first RIGHT off ramp (sharp turn). Take RIGHT at the stop light onto Union Avenue (under bridge). Take first RIGHT onto W. Water Street. Proceed two blocks to the stop sign and take a LEFT onto S. Orange Street. First building on LEFT is the rear of the Gateway Center.

#### I-95 from New York

Take I-95 North to New Haven, Exit 47 (Downtown, left hand exit) Move quickly over to the right. Look for Coliseum and Railroad Station signs. Take Exit 1 off connector and take first RIGHT off ramp (sharp turn). Take RIGHT at the stop light onto Union Avenue (under bridge). Take first RIGHT onto W. Water Street. Proceed two blocks to the stop sign and take a LEFT onto S. Orange Street. First building on LEFT is the rear of the Gateway Center.

## **Merritt Parkway**


