Re: Self-Report of Team and Individual Practice Requirement Violation

Dear Mr. Simon,

I am writing to self-report a violation of the 7-day practice rule, 5.6.G. by the North Haven High School baseball program.

As you know, Rule 5.6.G. states "No team/athlete shall practice/compete with their school more than six (6) consecutive days to provide a day of rest. Saturdays, Sundays and holidays may be used unless prohibited by local board policy." Unfortunately, our baseball team practiced seven days in a row recently.

Upon hearing about this potential violation, our Director of Athletics, Steve Blumenthal, contacted our new head baseball coach, Joe Romanelli. They discussed what had occurred, and Coach Romanelli put his explanation into writing:

"In regards to practicing 7 days last week, my thought process was to not have the players practice on Easter because I know most of the players celebrate that holiday. With this in mind and the consistent changes in our practice schedule the first week of the season due to cancellations of the Danbury game, I had an hour long light practice on Saturday morning to try and keep the boys fresh for our game on Monday. I did this instead of having two days off (Saturday and Sunday) especially now with the Danbury game moved to this Saturday and playing 4 games in 6 days. I now realize my error in this decision and I apologize. I will be more mindful in the future of the practice and game schedule of the week and not to practice 7 days consecutively."

As Coach Romanelli expressed personally and in writing, he will not make this mistake again and has learned from this situation. We appreciate his perspective, and we want you and the CIAC to know that we take very seriously this violation and our overall adherence to CIAC regulations.

Here is our plan to ensure that this mistake will not occur again:

- The head baseball coach will meet with the athletic director to review the CIAC Rule 5.6.G. and regularly to review general practices and any questions or issues the coach may have.
- The head coach of the baseball team will take CIAC Module 5, "CIAC Rules and Regulations."
- For the remainder of the 2023 spring season, the head coach will submit to the athletic director a practice plan for the upcoming week on the preceding Thursday.
- All preseason meetings with head coaches and sub-varsity coaches for all sports will continue to explain and reinforce CIAC rules and regulations.
- All new coaches will take CIAC Module 5, "CIAC Rules & Regulations" as a pre-employment requirement, in addition to other district professional development trainings.
- The athletic director will propose a professional development cycle with refresher training to keep coaches informed and updated on regulations, laws, and best practices. This PD cycle will include CIAC Module 5, "CIAC Rules & Regulations".

I appreciate your attention to this matter and apologize for the violation. Learning that this violation occurred was disappointing. The North Haven High School administration and athletic department hold ourselves to high standards. We will take the concrete steps defined above to ensure this error is not repeated. We welcome your feedback on this plan and input into making this situation right.

Mr. Simon,

Bulkeley High School is formally sending to the CIAC Board of Control a letter of self-report for a player that was academically ineligible for the 2nd marking period.

Tidy Joy is a member of the Bulkeley/SMSA Boys' Volleyball Cooperative team. When the 2nd marking period grades were checked for eligibility, an oversight was made as he did not pass 4 classes. He was given the green light to participate and play from the Athletic Director Diane Callis, as she determines the eligibility for all of our athletes. The oversight was recognized when the 3rd marking period grades were checked for all the athletes. We immediately notified the CIAC and did not allow Tidy to compete until he was cleared by CIAC. Tidy is now eligible with his 3rd marking period grades as he is getting support due to some home issues during marking period 2. During the 2nd marking period, the team played 5 games. Please see the schools, dates and results below. We understand that we will have to forfeit our wins during that time.

April 4th vs Rockville - loss 3-0 April 6th vs Putnam - win 3-1 April 12th vs Maloney - loss 3-0 April 13th vs NFA - loss 3-1 April 17th vs Innovation - win 3-0

As we continue to strive for excellence within our athletic program, we will take additional steps to ensure that grades are being looked at diligently. With cooperative programs, we can use the resource of our partner school AD to make sure we are checking and double checking. Bulkeley High School Athletic Department has worked hard with their student-athletes with behavior, sportsmanship and their academics as we have had a "C" rule in effect for many years. We as adults don't like to make these mistakes as we only hurt our student-athletes and the teams they are on.

An athlete may change sports up to the date of the first scheduled varsity contest in the sport he/she wishes to leave. However, an athlete may NOT change teams or sports after the first scheduled varsity contest in the sport he/she is leaving, even if athletic eligibility has not been declared.

6.0 Eligibility

6.9 CHANGING TEAMS

An athlete may change sports up to the date of the first scheduled varsity contest in the sport he/she wishes to leave. However, an athlete may NOT change teams or sports *once that student has* participated in a contest at any level or seven days after the first scheduled varsity contest in the sport he/she is leaving.
