# INTRODUCTION OF CIAC OFFICIALS ASSOCIATION ADVISORY BOARD MEMBERS

The advisory board members introduced themselves to the group. Joe T expressed his thanks for the excellent cooperation and support that CIAC has received from the Advisory Board.

#### **WELCOME & REMARKS**

# Glenn Lungarini, CAS-CIAC Executive Director

Glenn welcomed the group and shared that his dad was a long-time football official for the Western Board so he has a definite appreciation for the difficult job they have and their numerous contributions to the game. Glenn pledged the support of CIAC to their efforts.

# **Gregg Simon, CIAC Associate Executive Director**

Gregg mentioned the challenge of recruiting more officials and that CIAC will continue to assist in this regard. He also officially welcomed Dan Scavone to the CIAC Executive Staff. With Joe's retirement, Dan will assume the role as the Director of the CIAC Officials Association and will serve as the CIAC Liaison to several sports committees. Dan will also remain as the assistant tournament director and assigner of officials for the boys and girls basketball tournaments. Joe T stated that Dan is a perfect fit for the position and he will do a great job.

# Matt Fischer, CAS-CIAC Director of Technology

Matt updated the group on the Arbiter Game scheduling program that will be implemented this fall. The program accomplishes the goal of having one system for schools and practically all assigners. Athletic Directors and administrative assistants took part in comprehensive training sessions provided by Arbiter experts to learn the new system. Matt also attended league meetings to provide additional information and support to schools. Arbiter also provided instruction to the assigners, since some minor adjustments would be necessary on their end as well. Matt said there will be the growing pains with any new venture, but he is convinced that the system will be beneficial to all parties. He asked everyone for their patience, and to give "it a year" and everyone will hopefully experience positive results. The CIAC has made a significant financial commitment to the Arbiter game program. Matt also discussed rule book apps which will be an added benefit for National Federation Officials Association members. Basically, for every rule and/or case book purchased from CIAC by a NFHS board, that board will be entitled to one (1) free license for a rules app. The road map to expedite the process will be provided. This is a new

# RECRUITMENT STRATEGIES / RECRUITMENT SURVEY / BEST PRACTICES MOVING FORWARD Dan Scavone, New Director, CIAC Officials Association

Dan Scavone gave an overview of the Recruiting Survey which was completed during the 2017-2018 school year and presented at last year's Statewide Meeting. Important points that were highlighted included key reasons why officials leave the profession and best practices used by local boards to recruit and retain officials. Examples of positive recruitment strategies were shared with meeting attendees. An excellent video, created in collaboration with the Southwest Conference and IAABO Basketball Board #9 – Fairfield County, was shown. The video featured a Junior IAABO Training Program targeting high school students who have an interest in basketball officiating. In addition to the video, handouts were distributed providing detailed information on the objectives and history of the program, the permission form used, and a complete summary with future initiatives. It was emphasized that this program can be applied to any sports officiating group and those in attendance were urged to implement similar programs by working with the respective league/schools they service.
